

# Berwick Parish Council

Minutes of the Full Council Meeting of Berwick Parish Council held at the Berwick Village Hall on 22<sup>nd</sup> November 2018 at 7:30pm

61. Present

Cllrs K Winter (Acting Chairman), V Burrough and C Bird.

County Councillor N Bennett, Alison Stevens (Clerk) and one member of the public were also in attendance.

62. Apologies for absence

Councillors B Smith, D Robinson and S Carnie sent apologies for their absence which were duly accepted by the Parish Council.

District Councillor P Ede also sent apologies for his absence.

63. Declaration of Interests

There were no declarations of interests nor were there any changes to the Register of Interests.

The meeting was then suspended.

64. Reports from County Councillor

County Councillor Bennett said;

- ESCC has to find further cuts of £46m and it is asking for residents' views. He also said the County Council has put a case forward to Central Government which identifies why such savings here are just not feasible.
- He is waiting for an update on the ESCC response to the Wealden Local Plan. ESCC is worried because the increase in housing numbers will affect our roads and our environment and it also questioned how Wealden distributes the Community Infrastructure Levy.
- ESCC has some Community Match Funding still available. If anyone has some minor works they would like help with, please let him know. Councillor Bird suggested laying a path between Berwick and the Arlington Reservoir. This will be an agenda item for the next meeting. He will let the Clerk have more specific location details and the Clerk will approach County for costings or a ballpark figure.

65. Report from the District Councillor

There was no report from the District Councillor on this occasion.

66. Public Question Time

The owner of Amarisa asked that the hedge opposite his Bed and Breakfast is cut. The Clerk will contact the landowner.

## 73. Proposal to Review the Parish Boundary

Berwick Parish Council has been approached by Alciston Parish Meeting and Selmeston Parish Meeting and asked to review its boundary to include the villages of both Alciston and Selmeston.

The Parish Council would need to be disbanded and a new one set up.

The Parishes affected would also need to petition Wealden for a Community Governance Review (CGR) and 50% of residents would need to agree to the petition.

An election would need to be held following the CGR and because it would not be combined with any other poll, Wealden estimate the costs would be £1835.92 for Alciston, £2055.22 for Berwick and £1881.19 for Selmeston.

Councillors agreed they would like to consider this in more detail at the Full Council Meeting in January to allow for people to be present and asked the Clerk to invite the Chairman of Alciston Parish Meeting and the Chairman of Selmeston Parish Meeting to that meeting.
